We have tried to "hold the line" with our fees over the last 2 years during this economy downslide, however, to be able to continue to offer the detail oriented meticulous care, we must increase our fees slightly **effective 9/1/11**. We truly regret having to make this decision at this time. Let's all keep our optimism that these economic times will be relatively short lived. Thank you for your understanding.

New patient fees are as follows:

Consult/1hour evaluation = \$675.00

One hour of "face to face" time + chart review + dictation and production of formal written report

<18months of age, 2 visit evaluation = \$1250.00*

Two visits, one hour each of "face to face" time + chart review + dictation and production of formal written report

18 months and above, 3 visit evaluation = \$2100.00*

Three visits, one hour each of "face to face" time + chart review + dictation and production of formal written report
Each new patient evaluation includes a total of three visits as outlined in our practice brochure and a formal written report. The fee is for face to face time with you and your child, chart review, dictation and production of the formal written report. Please also be aware that if your child has had previous evaluations and you bring copies for the doctor to review, there will be an additional charge of *\$315.00 for the additional record review.

*Payment is due at the end of the first appointment, a completed claim form will be provided at the end of the third appointment.

Re-evaluation fees are as follows:

15 minutes of "face to face" time + chart review + dictation and production of formal written report= **\$165.00**

30 minutes of "face to face" time + chart review + dictation and production of formal written report= **\$315.00**

45 minutes of "face to face" time + chart review + dictation and production of formal written report= **\$430.00**

60 minutes of "face to face" time + chart review + dictation and production of formal written report = **\$515.00**

1 hr 15 minutes of "face to face" time + chart review + dictation and production of formal written report = **\$630.00**

1 hr 30 minutes of "face to face" time + chart review + dictation and production of formal written report = **\$755.00**

Phone appointment charges: (quick medication checks-no written report)

5 minutes = \$20.00

5-10 minutes = \$50.00

10-15 minutes = \$80.00

Letters (other than written report from evaluation):

\$10.00 for standard letters if we have as a standard in our computer system.

If a unique letter is required there will be a charges based on amount of time to gather the information, dictate, and produce. The fee will be discussed with you prior to the production of the letter.

Copies of other records, forms, etc:

There is a charge for the reproduction of any document. Please speak with office staff about exact fee for your request. We encourage you to have all copies made prior to your visit.

*There may be additional charges for record review if your previous records are extensive.
